

RESOLUTION NO. 2004-10-61

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, RELATING TO BOARDS AND COMMITTEES; APPOINTING MEMBERS TO SERVE ON THE REVENUE ENHANCEMENT COMMITTEE; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, at the October 22, 2003 City Council meeting Vice Mayor Campbell made a motion to create a Revenue Enhancement Advisory Committee, this motion was seconded by Councilman Bratton and unanimously approved by the City Council; and

WHEREAS, the primary objectives of the Revenue Enhancement Advisory Committee shall be as follows: 1) Evaluate the adequacy of the City's existing revenue structure; 2) Identify, analyze and assess the new sources of additional revenues; 3) Direct their analysis and assessments toward enhancing the City's revenue system; and 4) Explore the various methods of revenue collection and accounting; and

WHEREAS, The composition of the Revenue Enhancement Advisory Committee shall consist of no more than nine individuals with expertise including but not limited to municipal finance, operations, management, and economic development, but specifically excluding governmental and political lobbyist; and

WHEREAS, Each Council member is authorized to appoint a representative for the Revenue Enhancement Committee; and

WHEREAS, The Mayor is authorized to establish a commencement Sunset period. This Committee is governed by the Sunshine law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA AS FOLLOWS:

Section 1: Appointment of Committee Members. The following individuals are hereby appointed to the Revenue Enhancement Committee: 1) Frank Hall, appointed by Councilwoman Pritchett; 2) Daryl Jones, appointed by Councilman Braynon; 3) Lanette Jones, appointed by Councilman Bratton; 4) Anthony Brunson, appointed by Councilwoman King; 5) Claudia Dixon, appointed by Councilwoman Watson; 6) Brian D. Nevel, appointed by Vice Mayor Campbell; and 7) Linda Dosal, appointed by Mayor Gibson.

Section 2: Effective Date. This Resolution shall become effective immediately upon adoption.

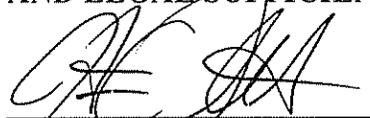
