

RESOLUTION NO. 2005-07-184

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO SUBMIT A PROPOSAL TO THE MIAMI-DADE COUNTY METROPOLITAN PLANNING ORGANIZATION CONCERNING A PROTOTYPE TRANSPORTATION-ORIENTED REDEVELOPMENT CONCEPT FOR THE INTERSECTION OF NORTHWEST 27TH AVENUE, NORTHWEST 183RD STREET/NORTHWEST MIAMI GARDENS DRIVE; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Miami-Dade Metropolitan Planning Organization ("MPO") has issued its Year 2005 Transportation Studies - Call For Ideas!, and

WHEREAS, the MPO is requesting submittals of any new transportation-oriented redevelopment ideas from various municipalities who participate in the MPO, and

WHEREAS, one of the areas of interest for the City of Miami Gardens is the intersection located at Northwest 27th Avenue and Northwest 183rd Street/Northwest Miami Gardens Drive, which is the existing site of the Carol City Shopping Center area, and

WHEREAS, this intersection will play a very important role in the transportation-oriented redevelopment for the City, and

WHEREAS, the City Manager recommends that the City Council for the City of Miami Gardens submit to the MPO a proposal for a prototype transportation-oriented redevelopment concept at the above-referenced intersection.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Council for the City of Miami Gardens hereby authorizes the City Manager to submit to the Miami-Dade County Metropolitan Planning Organization, a proposal for a prototype transportation-oriented


redevelopment concept for the intersection located at Northwest 27th Avenue and Northwest 183rd Street/Northwest Miami Gardens Drive.
