

RESOLUTION No. 2005-13-190

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE MANAGER TO EXECUTE A WORK AUTHORIZATION/TASK ORDER WITH KEITH AND SCHNARS, P.A., IN AN AMOUNT NOT TO EXCEED FIFTY-FOUR THOUSAND EIGHT HUNDRED FORTY-ONE (\$54,841.00) DOLLARS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on May 12, 2004, the City of Miami Gardens entered into a Continuing Services Contract with Keith And Schnars, P.A., pursuant to the Consultants' Competitive Negotiation Act, and

WHEREAS, the City of Miami Gardens was awarded a One Hundred Fifty Thousand (\$150,000.00) Dollars grant by the Dade County Landscape Committee to install landscaping along the roadway medians and shoulders of a major entry point into the City of Miami Gardens, and

WHEREAS, the City intends to use those funds for landscaping along Northwest 2nd Avenue from 179th Street to the I-95 ramp and the 7th Avenue extension, and

WHEREAS, the entire project is estimated to cost between Three Hundred Fifty Thousand (\$350,000.00) Dollars to Four Hundred Thousand (\$400,000.00) Dollars, and

WHEREAS, the City anticipates receiving funding from Miami-Dade County and the Florida Department of Transportation ("FDOT") for the landscaping and irrigation requirements, and

WHEREAS, the City Manager is recommending that the City utilize the services of Keith And Schnars, P.A. to provide the landscape design and plans for the proposed project in accordance with the Work Authorization/Task Order, attached hereto as Exhibit "A",

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.



AUTHORIZATION: The City Council for the City of Miami Gardens hereby authorizes the City Manager to execute the Work Authorization/Task Order with Keith And Schnars, P.A., attached hereto as Exhibit "A", pursuant to the Continuing Services Contract entered into between the City of Miami Gardens and Keith And Schnars, P.A. on May 12, 2004.
