

RESOLUTION No. 2006-09-355

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXTEND THE AGREEMENT APPROVED UNDER RESOLUTION NUMBER 2005-20-197 WITH MIAMI-DADE COUNTY FOR COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING FOR A FACADE RESTORATION PROGRAM IN THE MAXIMUM AMOUNT OF THREE HUNDRED THOUSAND (\$300,000.00) DOLLARS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Miami Gardens previously submitted requests for CDBG funding to Miami-Dade County for several City of Miami Gardens' programs, and

WHEREAS, the City of Miami Gardens has been approved by Miami-Dade County for the Program in the amount of One Thousand (\$100,000.00) Dollars and although the City has put forth its best effort to complete the program, the complexities of the process and the delayed execution of the agreement has made it necessary to request an extension of time to complete the program, and

WHEREAS, prior to finalizing the approval of the extension of the agreement Miami-Dade County has requested that the City provide authorization for someone to execute documents on behalf of the City of Miami Gardens, and

WHEREAS, the City Council would like to designate the City Manager as the person with the authority to execute the documents attendant to the City's receipt of CDBG funding from the County, subject to the review and approval by the City Attorney,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. APPROVAL/AUTHORIZATION. The City Council for the City of Miami Gardens hereby authorizes the City Manager to extend one (1) contract with Miami-Dade County for the maximum amount of Three Hundred Thousand (\$300,000.00) Dollars for a Facade Restoration Program into Fiscal Year 2006 ending on December 31, 2006, and, further, authorizes the City Manager and City Clerk, respectively, to execute the same, for and on behalf of the City of Miami Gardens, subject to the review and approval by the City Attorney.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
