

RESOLUTION No. 2006-19-365

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, REPEALING RESOLUTION NO. 2004-10-61 WHICH APPOINTED MEMBERS TO THE REVENUE ENHANCEMENT ADVISORY COMMITTEE; DISBANDING THE REVENUE ENHANCEMENT COMMITTEE; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, at the October 22, 2003 City Council meeting, the City Council established the Revenue Enhancement Advisory Committee, and

WHEREAS, on January 14, 2004, the City Council appointed members to the Revenue Enhancement Advisory Committee pursuant to Resolution No 2004-10-61, and

WHEREAS, the primary objective of the Revenue Enhancement Advisory Committee are to 1) Evaluate the adequacy of the City's existing revenue structure, 2) Identify, analyze and assess new sources of additional revenues, 3) Direct their analyses and assessments towards enhancing the City's revenue system; and 4) Explore the various methods of revenue collection and accounting, and

WHEREAS, the stated purposes for the Revenue Enhancement Advisory Committee no longer exist, as City staff members are capable of performing the services that were a part of the objectives of the Revenue Enhancement Advisory Committee,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS.

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution

Section 2. DISBAND/REPEAL: Resolution No. 2004-10-61 that appointed members to the Revenue Enhancement Advisory Committee is hereby repealed.

Moreover, the City Council for the City of Miami Gardens hereby disbands the Revenue Enhancement Advisory Committee.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
