A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING AN ANNUAL CITY HOSTED MEMORIAL DAY BREAKFAST TO BE HELD AT THE CITY OF MIAMI GARDENS COMMENCING IN 2006; AUTHORIZING THE CITY MANAGER TO TAKE ALL STEPS NECESSARY FOR THE CITY TO HOST THE BREAKFAST; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City would like to formalize the hosting of an annual Memorial Day breakfast commencing with the first event on Monday, May 29, 2006,




