

ORDINANCE NO. 2007-20-126

AN ORDINANCE OF THE CITY OF MIAMI GARDENS, FLORIDA, AMENDING THE CITY'S BUDGET FOR 2006-2007 FISCAL YEAR; CREATING CERTAIN FUNDS; AUTHORIZING THE CITY MANAGER TO MAKE CERTAIN ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO TAKE ALL ACTIONS NECESSARY TO IMPLEMENT THE TERMS AND CONDITIONS OF THIS ORDINANCE; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in accordance with Section 4.5 of the City of Miami Gardens Charter, the City Council adopted a Budget for Fiscal Year 2006-2007, and

WHEREAS, the City Manager recommends that the City establish certain accounting funds for the FY 06-07 budget, and

WHEREAS, it is appropriate to provide for certain transfers, appropriations and authorizations based upon previous and anticipated expenditures and revenues,

WHEREAS, the City Council has determined that it is necessary to amend the budget to reflect these changes,

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

SECTION 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas Clauses are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Ordinance.

SECTION 2. AMENDMENT TO BUDGET:

A. The following amounts are hereby transferred for the operation and maintenance of the various Funds below, said monies currently appropriated as part of the adopted annual operating budget for the fiscal year beginning October 1, 2006, and ending September 30, 2007:

B. The following amounts are hereby appropriated as part of the adopted annual operating budget for the fiscal year beginning October 1, 2006, and ending September 30, 2007:

C. The City Manager is authorized to establish the State Housing Incentive Partnership (SHIP) Grant Fund in the amount of the grant received, \$613,000 and to establish a separate bank account per grant requirement to hold such funds.

SECTION 3. INSTRUCTIONS TO THE CITY MANAGER: The City Manager shall take all actions necessary to implement the terms and conditions of this ordinance.


SECTION 4. CONFLICT: All ordinances or Code provisions in conflict herewith are hereby repealed.

SECTION 6. EFFECTIVE DATE: This ordinance shall take effect immediately upon its passage.
