A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA AUTHORIZING A RENEWAL OF THAT CERTAIN AGREEMENT WITH WASTE MANAGEMENT, INC. OF FLORIDA FOR THE PROVISION OF REFUSE COLLECTION CONTAINERS AND DISPOSABLE SERVICES; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City initially entered into a contract with World Waste Services for refuse collection and leasing for a two (2) year term commencing November 2007, and

WHEREAS, in September 2009, that agreement was assigned to Waste Management, Inc., and

WHEREAS, the original agreement provided for an option for the City to renew for an additional four (4) years, and

WHEREAS, City staff is recommending that the City Council authorize a renewal of the existing agreement with Waste Management, Inc. for an additional two (2) year period,



Section 2: AUTHORIZATION: The City Council of the City of Miami Gardens hereby authorizing a renewal of that certain agreement with Waste Management, Inc. of Florida for the provision of refuse collection containers and disposable services at the City Parks, Public Works and Police Department facilities.

Section 3: EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.

Staff Summary:

Background

The City is in need of continued waste disposal services at our Parks, Public Works and Police Department facilities , a service referred to as refuse collection services. The refuse collection services contract was initially approved by City Council under Resolution No. 2007-159-666.1. It was awarded for an additional two- year term with the option for the City to renew the contract for two additional two-year terms, totaling four (4) years.

Agreement with Waste Management**

The City awarded this contract for the purpose of providing refuse collection of leased containers, roll-off containers and disposal services. These containers are used by our maintenance crews to dispose of litter and trash collected from the Right of Way, Parks, and other City facilities.

Current Situation

City staff is pleased with the current service provider, Waste Management Inc. of Florida and recommends that the contract be renewed for an additional two years. The expenditure for this service is approximately \$124,000 annually. The Purchasing Department issued a renewal notification letter to Waste Management Inc., requesting that the contract terms and conditions, and pricing remain the same during the two-year extension period. Waste Management, Inc. agreed to maintain the contract terms as requested. A resolution authorizing the City Manager to execute a contract extension is needed.

Proposed Action:

That the City Council approve the resolution authorizing the City Manager to exercise the contract extension with Waste Management, Inc. for an additional two (2) years. It is estimated that the City will spend \$124,000.00 for this service annually.
