A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING A 7% INCREASE TO THE CURRENT SALARY OF DR. DANNY CREW, THE CITY MANAGER; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Dr. Danny Crew, the City Manager, has served in that capacity for the last three (3) years, and

WHEREAS, during his tenure, Dr. Danny Crew has assisted the City with accomplishing many of its goals and objectives, and

WHEREAS, under Dr. Danny Crew's tenure, the City has started its own Police Department, initiated bond issues, received millions of dollars in grants and completed the City's first Comprehensive Development Master Plan, among other things, and

WHEREAS, in addition, Dr. Danny Crew has received multiple accolades individually and through his staff, including the Distinguished Budget Award, the Public Administration Award and an award for the City's Comprehensive Development Master Plan, and

WHEREAS, the City Council of the City of Miami Gardens would like to recognize Dr. Danny Crew's commitment to the City and his accomplishments,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. INCREASE: The City Council of the City of Miami Gardens hereby authorizes a 7% increase to Dr. Danny Crew's current salary. This confirms that all existing benefits shall remain the same. This increase shall be effective as of January 6, 2007.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
