A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA CANCELLING THE FEBRUARY 1, 2012 ZONING MEETING; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Special Election for Residential Area Seat Five is scheduled to occur the day immediately preceding the Zoning meeting, and

WHEREAS, Dade County Days in Tallahassee is scheduled to occur on the day of the Zoning meeting, and

WHEREAS, with several members of the Council planning to attend Dade County Days, and the unforeseeable outcome of the Special Election, it is anticipated that a quorum may not be reached for the Zoning meeting, and

WHEREAS, as such, staff recommends the adoption of a Resolution cancelling the Zoning Meeting scheduled for February 1, 2012,
