WHEREAS, pursuant to the Articles of Incorporation, the Mayor and City Council are to jointly appoint individuals to the initial Board of Directors, and

WHEREAS, Councilman Erhabor Ighodaro, Ph.D. recommends that the City Council appoint Guerline Bethel to the Board of Directors of the Friends of Miami Gardens, Inc.,




Section 3: EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
