

RESOLUTION NO. 2013-24-1820

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDED BIDS TO DANA SAFETY SUPPLY, INC. AND SIGNAL TECHNOLOGY ENTERPRISES, INC. FOR RETROFITTING OF POLICE VEHICLES; AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS, FOR THIS PURPOSE, IN AN AMOUNT NOT TO EXCEED FOUR HUNDRED FIFTY THOUSAND DOLLARS (\$450,000.00) AND FIFTY THOUSAND DOLLARS (\$50,000.00) TO DANA SAFETY SUPPLY, INC. AND SIGNAL TECHNOLOGY ENTERPRISES, INC., RESPECTIVELY; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on September 25, 2012, the City Council authorized the issuance of a bond, for the purchase of seventy-three (73) police vehicles, and

WHEREAS, the vehicles have been purchased, and must now be retrofitted for police services, and

WHEREAS, a solicitation was advertised on October 31, 2012, however all bids were rejected on December 12, 2012, in accordance with Resolution No. 2012-191-1786, and

WHEREAS, the solicitation was re-advertised on December 14, 2012 as #ITB-12-13-012, and

WHEREAS, on December 28, 2012, two (2) bids were received and publicly read, and City staff recommends awarding a bid for retrofitting services for marked Chevrolet Tahoe vehicles to Dana Safety Supply, Inc. located in Jacksonville, Florida, in the amount of Four Hundred Fifty Thousand Dollars (\$450,000), and

WHEREAS, City staff also recommends awarding a bid for the retrofitting of unmarked police vehicles, in an amount not to exceed Fifty Thousand Dollars (\$50,000.00) to Signal Technology Enterprises, Inc. located in Hialeah, Florida, and

WHEREAS, the contract will be for a one (1) year period with the option to renew for two (2) additional years,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA AS FOLLOWS:

Section 1: ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2: AUTHORIZATION: The City Council of the City of Miami Gardens hereby awards Bids to Dana Safety Supply, Inc. and Signal Technology Enterprises, Inc. for retrofitting of police vehicles. The City Council further authorizes the City Manager to issue purchase orders, for this purpose, in an amount not to exceed Four Hundred Fifty Thousand Dollars (\$450,000.00) and Fifty Thousand Dollars (\$50,000.00) to Dana Safety Supply, Inc. and Signal Technology Enterprises, Inc., respectively.

Section 3: EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
