

ORDINANCE NO. 2013-10-298

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, RESCINDING ORDINANCE NO. 2008-19-155, AS AMENDED, WHICH CREATED THE CITY OF MIAMI GARDENS' PROGRESSIVE YOUNG ADULTS COMMITTEE; AUTHORIZING THE DELETION AND RESERVATION OF SECTIONS 2-312 THROUGH 2-317 OF THE CODE OF ORDINANCES; PROVIDING FOR ADOPTION OF REPRESENTATIONS; REPEALING ALL ORDINANCES IN CONFLICT; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR INCLUSION IN CODE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Miami Gardens has created various committees to assist the City Council advisory capacities, and

WHEREAS, many of these committees are no longer functioning due to various reasons, including lack of appointments, lack of quorums etc., and

WHEREAS, the City Council, in an effort to make government operations more efficient, has decided to rescind some of the Ordinances that created certain committees, and

WHEREAS, the Progressive Young Adults Committee was created for the purpose of advising the City Manager and City Council informed of issues that affect the City's young adults and to give advice respects to those issues, and

WHEREAS, the City Council has decided to sunset the Progressive Young Adults Committee,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Ordinance.

Section 2. RESCINDING OF ORDINANCE: The City Council of Miami Gardens hereby rescinds Ordinance No. 2008-19-155, as amended, which created the Progressive Young Adults Committee, and authorizes the deletion and reservation of Sections 2-312 through 2-317 of the Code of Ordinances.

Section 3. CONFLICT: All ordinances or Code provisions in conflict herewith are hereby repealed.

Section 4. SEVERABILITY: If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance.

Section 6. EFFECTIVE DATE: This Ordinance shall become effective immediately upon its final passage.


